# The next order of business

# 114-514. Supervision.

- A. (2) After Cynthia Lara consulted with Kenneth Smith, Chief Fire Marshal, it was clarified that another caregiver needs to be present when there are 3 children under the age of 24 months. Tex Davis also compared this to the Family Child Care Home regulations.
- B. (1) Tammy Compton asked if this was ok to be removed; Rachel Ellis nodded yes then several others nodded in favor and agreed upon to read:
  - (1) During nap times staffing ratios do not change.
- C. (1) Jessica Sharp suggested removing the term wading pools and Rachel Ellis suggested it should match center regulations.

Based on comments by the Committee, Tex Davis recommended that the language in this section be aligned with the language for the similar section in the proposed revisions to the Center regulations.

(2) Tex Davis recommended striking the revised language and Jessica Sharp also agreed.
