This guide supports Child and Adult Care Food Program (CACFP) operators in implementing the CACFP infant meal pattern requirements and best practices for infant feeding, including information on:

- CACFP infant meal pattern, developmental readiness for solid foods,
- hunger and fullness signs,

**REMINDER: DID YOU KNOW?** 

Effective June 2018, the Child Care Center Regulations were changed to reflect that

NO Corporal Punishment shall be used against children. All teacher/caregivers shall sign a facility agreement to implement the discipline and behavior management policy, with a statement that specifies No Corporal Punishment. There are no exceptions to this regulation.

This means that children shall not be hit, kicked, punched, slapped, pinched, etc., in anyway by anyone in the Licensed Child Care Center. Positive reinforcements should be used to redirect children when needed. If you would like additional information on how to manage children, please let your Licensing Specialist know, and we will be happy to make a referral with our Child Care Resource and Referral partner to assist you.

DSS Regulation 114-507C(2) states that furniture, toys, and recreational equipment shall meet the standards of the US Consumer Products Safety Commission (CPSC), if applicable, and that recalled products shall not be accessible to children. # **National Water Safety Month**



May is National Water Safety Month. Water is fun for kids but can also be hazardous. Among preventable injuries drowning is the leading cause of death for children ages 1 to 4. Infants and toddlers can drown in less than two inches of water. This can happen when and where you least expect it, including bathrooms, small areas of water around your home such as ponds or rainfall puddles, and in inflatable pools. Most drowning injuries or deaths are preventable.

# Swimming Safety

- Dress children in Coast Guard-approved flotation devices/life vests (with snug fit)
- Children younger than five should wear a vest with a head support and a strap between legs.
- Check for water conditions, such as currents and tides.

- Go Couture Children's Loungewear due to violation of federal flammability standard.
  - Target Wooden Toy Vehicles due to choking hazard caused by detachable wheels.
  - Flying Tiger Copenhagen Toy Train Carts due to choking hazard caused by steam dome coming loose.
  - TriDerma Pain Relief Cream due to failure to meet child resistant closure requirement.
    - Kids II Rocking Sleepers due to reports of infant fatalities.

### Injury

- Keep electrical appliances away from children when they are in or near water.
- Dress children in foot protection such as aqua socks or water shoes.
- Don't let children run or jump near water. Home Safety
- Completely empty all tubs, sinks, buckets, containers, and kiddie pools immediately after use.
- Close toilet lids, and use toilet seat locks.
