

License Exempt Health & Safety Inspection Visits



ABC Quality staff are scheduling health and safety inspection visits with licensed-exempt early childhood programs participating in the ABC Quality program.

ABC Quality staff will follow Center for Disease Control and Prevention (CDC) and Department of Health Environmental Control (DHEC), health and safety guidelines upon entering licensed-exempt program's building for inspection.


