- Battat Infant Teethers, due to choking hazard caused by detachable plastic wings.
- Target Cat & Jack Baby Rompers, due to choking hazard caused by detachable heart-shaped graphics.
- Playgro Infant Activity Rattles, due to choking hazard caused by dislodging abacus ring.
- BRAV USA Youth Jackets with Drawstrings, due to strangulation and entrapment hazards.
- YYBA Welmate Lidocaine Numbing Cream, due to failure to meet child resistant packaging requirements.
