





Prevent Vehicular Heatstroke



Each year, scores of children die from vehicular heatstroke with 24% of incidents occurring while a parent or caregiver was at a place of work.

The SCDSS's Division of Early Care and Education wants to remind you to never leave a child in a hot car -- even if the window is open or if you park in the shade.

You can educate yourself and everyone you know about this preventable danger. The National Safety Council has a free online course about the danger of vehicular heatstroke and children, the three primary circumstances that lead to children dying, and what we all can do to prevent these deaths.
