Attendance at a child care facility may expose a child to an increased risk of acquiring infectious diseases. Many types of infectious germs may be contained in human waste (urine, feces) and bodily fluids (saliva, nasal discharge, tissue and injury discharge, eye discharge, blood, and vomit). Hand washing is key to prevention and control of infectious disease. The following list addresses but is not limited to the times hand washing must occur.

- Hand washing by children to prevent the spread of germs:
 - o After using the restroom
 - After outdoor play
 - o Before/after eating a meal or snack
 - After handling animals
 - After art activities
- Hand washing by the staff to prevent the spread of germs:
 - Prior to preparing food
 - o After contact with children while preparing food
 - o After coming in contact with any bodily fluids
 - After applying medication
 - o After cleaning
 - After handling trash/garbage

Current immunization of children is another way to control and prevent the spread of infectious disease. In South Carolina, under the authority of the Department of Health and Environmental Control (DHEC), school districts are responsible for ensuring verification of immunization records for children aged 5 and up.

children's hands are washed regularly to ensure the prevention and control of infectious disease. Any outbreaks of infectious disease (1 or more children) are reported to Child Care Licensing (licensed centers, licensed/registered family child care homes/groups) or ABC Quality (license-exempt centers). Our program conducts regular cleaning and disinfection schedule of areas where children can be exposed. Staff maintain current health assessments and TB tests. For license-exempt programs only – copies of current children immunization records for homeschooled students are kept on file.
