#### Meal Pattern Revisions: CACFP Supports Breastfeeding.

On October 1, 2017, the following meal pattern revisions will take effect for child care facilities that participate in the Child & Adult Care Food Program:

· Infant meal patterns will have two groups: 1. Birth through the end of 5 months 2. 6 months through the end of 11 months



- Introduce solid foods when the child is developmentally ready, about 6 months of age.
- The new age groups are consistent with the recommendations of the American Academy of Pediatrics and the Women, Infant and Children (WIC) program. They are also simpler for child care facilities.
- New age groups will encourage exclusive breastfeeding for the first six months of life in two ways:
  - 1. Providers may continue to claim infant meals for reimbursement when a parent or guardian supplies expressed breastmilk for their infant that is fed to the infant.
  - 2. Child care facilities may begin to claim reimbursement for meals when a mother breastfeeds her infant at the child care facility.

## **Beginnings SC Provides Free Hearing Screenings**

Hearing loss is a disability that is often late-diagnosed and vastly under-diagnosed. The incidence of permanent hearing loss is 1 in 100 school-aged children. That's nearly 12,000 children in SC alone. Unfortunately, estimates tell us less than 2,000 of these children have been properly diagnosed and are receiving the appropriate services and supports. In addition, 35% of children under age 5 who have ear infections can't hear well enough to learn language. Beginnings SC has worked with DSS as a partner agency since September 2015 to change that. More than 2,200 children have been screened for hearing loss using OAE (Otoacoustic emissions) technology. Beginnings SC is thrilled to partner with child care programs across the state to conduct free hearing screenings for children. But that isn't all Beginnings SC offers. Beginnings SC's staff are certified Technical Assistance providers! Beginnings SC has Certified trainers offering 2.0 credit hours of training in the topic area of Special Needs. Beginnings SC can help if you:

- Have a child with a hearing aid or cochlear implant in your center and want some tips;
- Have parents or staff with a hearing loss and want to learn how to involve them in your program; or
- Want a FREE, hands-on, comprehensive, and fun training about language development and hearing loss that is flexible and provided at the time and location that is more convenient for your child care program.
